Administrative/Biographical History:

"The upper ten miles of Willow Creek was one of the first steady sources of gold in the upper Cook Inlet region. Thus, by June 11, 1898, enough people were in the area that a meeting could be held at the nearby town of Knik, to formally define the Willow Creek Mining District. The miners voted to establish the boundaries as follows: '...commencing at mouth of canon and including all tributaries to the head waters of said Willow creek (sic).' [...] The early miners were few in number, and possibly drifted through the area, never staying long. They were mostly trappers who supplemented their incomes by panning for gold in the summer, when the streams were free of ice. One such person was Robert Lee Hatcher, from whom the present name for the Willow Creek area, 'Hatcher Pass,' was derived.

"Closely related to the early growth of Knik was the success of gold mining on Willow Creek. Herning's diaries provide most of the information for this period, and it is in his diary for 1898 that the earliest direct reference to mining on Willow Creek can be found."¹
