Administrative/Biographical History:

Joseph W. Graham arrived in Spenard, Alaska, circa 1954-1956. He was a co-owner, with W.R. Harvey, of Spenard Cesspool Pumping (also called Alaska Services). He purchased Kwik-Log, Inc. after the company had gone bankrupt. He served as Director of the Spenard Public Utilities District and Director of the Greater Anchorage Health District Board of Directors. Starting in 1963, he worked as an agent for Equitable, Inc., and was also operator of Jet Terminals, Inc., starting in 1961. He was involved with the Alaskan Right to Vote League, of which he served as president; the Foundation for American Principles and Traditions; and the Ptarmigan Toastmasters Club. He died in Anchorage on April 26, 2002, at the age of 80.

Scope and Content Description:

The collection consists of business records, meeting minutes, correspondence, maps, plans, and other ephemera pertaining to Kwik-Log, Inc.; the Spenard Public Utilities District; the Greater Anchorage Health District; and a fundraising campaign for Central Catholic Junior High School.

Arranged by topic and then chronologically.
