.4 – [H.R. Phillips? standing with woman, possibly his wife, both wearing fur parkas, fur pants, and mukluks]

.5 – [flight crew loading bedrolls and other supplies onto sled outside building with sign "General Merchandise, Teller Post Office," man at right probably proprietor, snowshoes propped against wall at right, Hills Bros. Coffee advertisement on wall at left]

.6 – Eskimos in skin boat, Alaska [Inupiaq in large umiak with mast in open water]

.7 – [man wearing fur parka and mukluks leading reindeer pulling sled, building in background]

.8 – [several dog teams with sleds on tundra, possibly lined up for race, buildings in background]

.9 – [sled dog tied near building, wagon wheel half buried in snow]
