Administrative/Biographical History:

The Anchorage Presbyterian Hospital opened in 1963 on 8th Avenue and L Street in downtown. In 1968, the name was changed to Anchorage Community Hospital. In 1976, the hospital was sold to the Teamsters, renamed Alaska Hospital and Medical Center, and moved to Debarr Road. Ongoing financial difficulties led to the sale of the hospital to Humana in 1982.

Ron Pavellas was born in 1937. He came to Alaska from California in 1979 to serve as administrator for the Alaska Hospital and Medical Center.

Scope and Content Description:

The collection consists of 27 black-and-white photographs and news clippings collected by Ron Pavellas during his time as an administrator of Alaska Hospital and Medical Center. For more information, see Detailed Description of Collection.
