### Administrative/Biographical History:

Anna Caroline *David* Butler was born December 20, 1913, in a log cabin in Knik, Alaska. She was the daughter of Leopold David, Anchorage's first mayor, and Anna *Karasek* David. She married Bernard James Butler and died in Seattle, Washington, in 2021.

Anna Caroline's father, Leopold David (b. 1881, d. 1924), was an early Anchorage civil leader and served as doctor, lawyer, mayor, and judge at different times in southcentral Alaska. While working in Seward, he met Anna Karasek (b. 1883, d. 1971) whom he married in 1909. Karasek was a teacher who lived in Ketchikan, Alaska, prior to marriage where she taught in the Grammar Department at the public school. In 1910, she taught in Seward. The couple had two children, Anna Caroline, and Leopold, Jr.

## Scope and Content Description:

The collection consists of 99 items, including photographic prints, commercially produced photographic postcards, ephemeral materials, and one panorama with negatives. The photographic prints depict the David family and some of the various locations where Leopold

worked. Several postcards are addressed to Miss Anna Karasek and show various towns in southeast Alaska including Tlingit and Haida communities with totem poles. The collection also includes several photographic postcards of shipwrecks. For more information, see Detailed Description of Collection.

Arrangement: Collection arranged when inventoried in 1973 and cataloged in 1978.

# **Processing Note**

The collection was inventoried by Ola M. Hughes in March and April 1973. The collection was catalogued in 1978 by Jeanine Felker (Archival volunteer) and MDB. The inventory lists 94 unique collection items, but did not include several items including one photograph, one memorabilia item, and some duplicate images. The duplicate images were assigned identification numbers in 1978, the unnumbered photo was assigned number B1971.071.73a in 2024, and the unnumbered memorabilia item is listed under Ephemera on the Finding Aid. In total, there are 99 items in the collection.

Item .65 was misnumbered as .66 when catalogued in 1978 but was corrected to .65 in July 2024

Items .13, .58, .59, and .67 were missing at 1978 cataloging. In July 2024, item .13 was located.
