**OVERVIEW OF THE COLLECTION**

Dates: circa 1929-1931

Extent: 36 items

Language and Scripts: The collection is in English.

Name of creator(s): Winter & Pond, Ordway, Schallerer, C. H. Hope, Valdez Drug Co.

**Administrative/Biographical History:**

The USCG cutter *Shoshone* was commissioned January 10, 1931. It logged 4,911 hours of Bering Sea duty during its career, in 1933-1936, 1938, and 1940. During the 1940 season (May-August), it reported first at Valdez. On the Seward to Unalaska cruise, it stopped at "three villages, where Public Health Service doctors, attached to the Patrol, afforded medical and dental aid to the natives."<sup>1</sup> After Unalaska, it headed to Bristol Bay and then stopped at Cape Sarichef and Scotch Cap. In May and June, it transported a patient from Perryville to Unalaska; delivered mail to the Pribilofs, Nome, and "a number of villages"; ferried King Islanders from Cape Prince of Wales back to their island; and transferred a patient from Savoonga and another from King Cove to Unalaska. In July, it again visited the Pribilofs, cruised Bristol Bay, stopped at Attu, adjudicated a murder case in King Cove, arrested three Chignik youths and

remanded them to Unga, and performed a marriage in Chignik. The ship was transferred to the United Kingdom in 1941 and rechristened the H.M.S. *Landguard*.

Scope and Content Description:

The collection includes 36 photographs and postcards, primarily of coastal towns visited by U.S. Coast Guard cutter *Shoshone* in 1931. Many of the postcards were commercially produced; the amateur photographer of the snapshots is unknown.

- .2 – Atka, Alaska [on verso:] 1930 [view of village buildings from water]
- .3 – 35. Juneau, Alaska, A.J. Mill. W.P. Co. [postcard. View of A-J Mine and Juneau waterfront from water]
- .4 – Franklin Street, Juneau, Alaska. W.P. Co. [postcard. Street view with automobiles, signs for businesses including Reliable Transfer, Alaskan Hotel and Café, Post Office Station No. 1]
- .5 – Residence District, Juneau, Alaska. 35035, Ordway, c. '31 [postcard. Bird's eye view of buildings]
- .6 – Alaska Juneau Gold Mining Co., c. '29, Ordway, 201 [postcard. View of A-J Mine from water]
- .7 – U.S. Coast Guard cutter Unalga at Ketchikan, Alaska [on verso:] 1931 [i.e. early 1930? Cutter at Ketchikan docks, near Northland Transportation Company warehouse and Ketchikan Cold Storage. USCGC *Unalga* reported to Seattle on July 26, 1930, and then to Maryland for repairs, returning to commission on the East Coast in 1932.]
- .8 – 1931 [sign on building reading “Kodiak, the home of the world's largest bear, for hunting expeditions for Kodiak grizzly, brown bear and caribou on Alaska Peninsula, polar bear and walrus in Siberian Arctic [see] Kodiak Guides Association”]
- .9 – Kodiak, 1930 [view of docks from water, Standard Oil Company terminal in foreground, W.J. Erskine warehouse at left. Original image blurry]
- .10 – 1931 [view of Kodiak docks from water, Russian Orthodox church at right, Church of the Resurrection?]
- .11 – Alaskan bald eagle. Alaska Shop [postcard. Bird flapping wings, perched on stump]
- .12 – 1930 [Navy personnel in uniform standing outside North Pole Bakery, baker standing in doorway, Shriners symbol on shop window, Fire Department at Nome Café in background]
- .13 – Seward, Alaska, U.S.T. Henderson, destroyers, President Harding, party aboard Aug. 1923. Schallerer's Alaska Shop [postcard. Bird's eye view of Seward docks and military ships in Resurrection Bay]
- .14 – Fur seals, St. Paul Island, Alaska [on verso:] 1930 [seal rookery]

- .34 – [Alaska Native man wearing parka with fur trim, mukluks, eyeglasses, and driving cap standing in street in front of wooden buildings; at AFN 2014, location suggested as St. Michael, with coal storage house in background at right. AT AFN, man identified as Ataayaghaq (Dr. Jimmie Otiyohok)]
- .35 – [Caucasian man wearing hip boots and brimmed hat standing on beach holding fishing rod and fish]
- .36 – [large group of men, women, and children, possibly on ship deck or on dock waiting for ship; at AFN 2013, location suggested as Unalaska. At AFN 2015, people identified as Pribilof Islands residents, with possibly John Golodoff second left rear wearing driving cap, and Sergei Tutakoff third left rear wearing driving cap, Hilda Berikoff in light-colored coat with hand on shoulder of Lila in front row]
