Administrative/Biographical History:

Ken Hinchey was born in 1912 in Washington State. In 1933, Ken married Nadine Graves in Oregon, and the couple moved to Alaska in 1937.

The Hincheys owned and operated a number of businesses in Alaska including transportation companies (Ken Hinchey Co., Pacific Western Lines), concrete and gravel operations (Alaska Aggregate Corporation (Alagco) and Idealaska Cement Co.), mining operations (placer gold inn Hope and coal in the Talkeetna Mountains), the Black and White Restaurant in Anchorage, and other ventures. They also were active in politics, especially during 1955-1956 when Ken campaigned for and then served as the mayor of Anchorage. Ken commissioned or built several things including tracked vehicles, tug boats, barges, freighters, and the icebreaker Knik Bay.

Ken Hinchey died in 1994.

Scope and Content Description:

Collection is comprised of Ken Hinchey's writings including one manuscript, two memos, and one short narrative. Notably, the manuscript contains a brief anecdote of Mayor Hinchey meeting with local businesswoman, Zula Swanson.

Arrangement: Original order maintained.
